I once again I have all the financial records for my past term as treasure, as well as those for the current fiscal year with me this month. The checkbook has been reconciled with the Wells Fargo bank statement. Because we reissued a reimbursement in the amount of \$42.06 to Liz Droze, our starting balance for this month is \$1116.44, not the \$1074.38 reflected in the October treasurer's report included in the minutes.

When doing this reconciliation, I discovered that I owe the area \$6.00 as a result of a \$10.00 overpayment (Check #2281 for \$104.07) and a \$4.00 underpayment (Check #2283 for \$104.98). This results in the \$6.00 overpayment. I have brought a check for that amount and will deposit into our bank account on a separate deposit. I will also note this on the treasurer's report so that the information will be available for any future audits.

I sent an email to Call Experts, followed up by a phone call, asking them to invoice the cost of our phone number but have not yet received a reply or an invoice.

I have contacted the Port City Chairperson, treasurer and PR chair and expect Port City to share the cost of purchasing our phone number from Call Experts. Port City has given me checks totaling \$132.32 and is current on the share of phone line cost since I have been treasurer, August 2017.
