CRSC Report
July 13, 2019

As promised, I represented South Coastal at the Regional Service Committee meeting this weekend. This was a very lively meeting. I will provide a more detailed report about the meeting when the meeting minutes are distributed. A proposal was made to spend \$2000.00 for the RD/AD team to travel to Dallas for a multiple zone CAT/CAR workshop.

The regional budget did not pass. All expenditures for the first quarter of 2019-2022 had to be approved by individual proposals because a budget is considered pre-authorization for all CRSC expenditures. A newer complete and updated budget is supposed to be distributed for area approval before the next CRSC meeting, Oct. 8, 2019.

The Southeast Zonal Forum guidelines did not pass. There were many concerns raised about member regions representation and voting procedures, as well as the lack of suitable financial guidelines.

A decision was made to not purchase a laptop for the regional treasurer to use. The RD from the Sun City Area donated one for the region to use. This will be entered as a regional asset in QuickBooks.

Pamela Hinton was elected as Treasurer and I was elected as Finance Chairperson.
